

AFF DRUG & ALCOHOL POLICY

1. AIM AND JURIDSTICTION

The AFF is committed to providing a safe and healthy sporting environment. This policy is aimed at minimising the risk of injury or harm to the health and safety of Registered Fencers, Relevant Persons, Officials and others from the use of alcohol or Drugs.

This Policy is governed by the Complaints, Disputes, and Discipline Policy (CDDP") adopted by the AFF.

2. COMMENCEMENT OF THE POLICY

This policy will commence on 1 December 2018 and is amended on June 26, 2024.

3. SCOPE

- 3.1 This policy covers the use of alcohol and other drugs, generally for recreational and social purposes. It is not intended to cover performance enhancing drugs, which are covered by the National Integrity Framework, specifically Improper Use of Drugs and Medicine Policy, and any subsequent changes. This policy:
 - (a) must be read in conjunction with all other AFF Sport policies, and the National Integrity Framework Policies adopted by the AFF; and
 - (b) is subject to any additional restrictions on the use of alcohol and other drugs which are imposed by the AFF in specific circumstances (for example, under the AFF Athlete Agreements and AFF Tour and Representation Rules).

3.2 This policy applies to:

- (a) all Relevant Persons as defined in the Complaints, Disputes and Discipline Policy; and
- (b) all Sporting Places and AFF Activities

4. RESPONSIBILITIES

4.1 All Relevant Persons must:

- (a) comply with this policy;
- (b) observe all directions from the AFF in regards to this policy; and
- (c) recognise that the performance of their Duties could be adversely affected by alcohol or drugs.

4.2 Except as set out in this policy, Relevant Persons must not:

- (a) possess, distribute, sell, use or consume Drugs or alcohol at Sporting Places or AFF Activities; or
- (b) perform Duties or attend Sporting Places while under the influence of Drugs or alcohol.

5. DRUGS

- 5.1 Subject to the qualification for Prescription Drugs and Pharmacy Drugs below, the AFF prohibits the possession, distribution, use or supply of Drugs:
 - (a) at any Activity or any other event sanctioned by the AFF; or
 - (b) in the performance of any Duties for or on behalf of the AFF.

Such conduct may result in action being taken in accordance with this policy, and the Complaints, Disputes, and Discipline Policy. It may also constitute a criminal offence, in which case the AFF may notify the police, or other appropriate authorities.

- 5.2 Where a Relevant Person is taking Prescription Drugs and Pharmacy Drugs for medical purposes, the Relevant Person will not be in breach of this policy if the Registered Fencer or Official if:
 - (a) takes the Prescription Drugs or Pharmacy Drugs in accordance with the instructions of their medical practitioner and normal directions applying to the use of those drugs;
 - (b) does not misuse or abuse the use of Prescription Drugs or Pharmacy Drugs; and
 - (c) ensures that he/she is able to perform his/her Duties effectively, competently and safely.
- 5.3 If the AFF suspects that a Relevant Person's ability to safely perform his/her Duties is affected, the AFF may take steps to address the issue in accordance with this policy.

6. ALCOHOL

- 6.1 The AFF recognises that at some sport related functions responsible consumption of alcohol is allowed, for example, at an official function. In these circumstances, the following restrictions apply:
 - (a) Relevant Persons must consume alcohol responsibly;
 - (b) Relevant Persons must not become inebriated. Inebriation does not diminish an individual's responsibility for misconduct; and
 - (c) Relevant Persons must ensure a safe means of transport from such functions. Registered Fencers and Officials must not drive any vehicle if they are over the legal blood alcohol limit.
- 6.2 If a Relevant Person is required to return to Duty, or continue Duty after a function, and the consumption of alcohol could adversely affect their ability to perform their Duties effectively and safely, consumption of alcohol by those Registered Fencers and Officials is not permitted.
- 6.3 If a Relevant Person breaches this policy at a sport related function and acts inappropriately, the Registered Fencer or Official may be subject to disciplinary action and may not be permitted to consume any alcohol at future sport related functions.
- 6.4 A Relevant Person may not consume alcohol while a participant on an Official tour irrespective of whether they have finished their events at the time of consumption.

7. SMOKING

- 7.1 Smoking is not permitted at or in the immediate vicinity of any Sporting Place hosting sporting events involving children and young people under the age of 18.
- 7.2 Activities sanctioned by the AFF will be smoke free, with smoking only permitted at designated outdoor smoking areas.
- 7.3 Relevant Persons will refrain from smoking while they are involved in an official capacity, both on and off the field of play.

8. WHERE SUSPECTED TO BE UNDER THE INFLUENCE

- 8.1 If the AFF suspects, on reasonable grounds, that a Relevant Person is under the influence of Drugs or alcohol in breach of this policy, the AFF will take steps to address the issue.

 Reasonable grounds may include where the Relevant Person
 - (a) is unable to co-ordinate their actions;
 - (b) has red or bloodshot eyes, or dilated pupils;
 - (c) smells of alcohol;
 - (d) acts contrary to their normal behaviour;
 - (e) is not behaving in a professional and competent manner; or
 - (f) otherwise appears to be impaired or affected by Drugs or alcohol and unable to perform their Duties.

In such circumstances, the AFF may take the one or more of following actions (and any other actions which are reasonable in the circumstances):

- (g) direct the Relevant Person to go home;
- (h) direct the Relevant Person to undergo a Drug Screen Test and/or Alcohol Screen Test; and/or
- (i) direct the Relevant Person to attend a medical examination to determine whether the member is fit to perform their Duties effectively and safely. The medical examination may include a Drug Screen Test and/or Alcohol Screen Test.
- 8.2 If a Relevant Person refuses to undergo a Drug Screen Test and/or Alcohol Screen Test or attend a medical examination, he/she will be directed to go home (at his or her own expense). Refusal to undergo a Drug Screen Test and/or Alcohol Screen Test, refusal to attend a medical examination, refusal to go home, or providing false information constitutes a breach of this policy and may result in action being taken in accordance with this policy (or any other AFF policy).

9. DRUGS OR ALCOHOL AT A SPORTING PLACE

- 9.1 If the AFF finds Drugs or alcohol at a Sporting Place or suspects that a Relevant Personl has Drugs or alcohol in their possession at a Sporting Place in breach of this policy, the AFF may take one or more of the following actions (and any other actions which are reasonable in the circumstances):
 - investigate the matter in order to attempt to determine who is responsible or whether a Relevant Person does have such Drugs or alcohol in his/her possession, including by conducting searches, as set out in this policy;
 - (b) request a Relevant Person to open their room, locker, bag, or vehicle or to empty their pockets or jacket for the purpose of locating any Drugs or alcohol; and/or
 - (c) require some or all Relevant Persons, to undergo a medical examination or Drug Screen Test and/or Alcohol Screen Test in order to test for the presence of Drugs or alcohol.
- 9.2 Relevant Persons are required to permit such inspection and co-operate in any investigation. Failure to co-operate, or providing false information in an investigation, constitutes a breach of this policy and may result in action as set out below under 'Breach of this Policy'.

10. DRUG OR ALCOHOL TESTING

- 10.1 The AFF may require a Relevant Person to undergo testing for the presence of Drugs or alcohol in the following circumstances, with or without, prior notice:
 - (a) Causal Based
 - (i) If the AFF suspects, on reasonable grounds, that a Relevant Person is under the influence of Drugs or alcohol in breach of this policy.
 - (ii) Upon finding evidence that a Relevant Person has used, possessed, sold, solicited or transferred Drugs whilst in a Sporting Place.
 - (iii) Upon receipt of a report of Drug or alcohol use in breach of this policy, provided by a reliable and credible source and confirmed by investigation.
 - (iv) Where a Relevant Person has previously received a positive Alcohol Screen Test or Drug Screen Test and has refused to undergo a Confirmatory Test, he/she will be required to undergo subsequent testing.
 - (vi) Where the AFF is conducting randomised testing amongst Relevant Persons.
 - (b) Targeted Testing
 - Where the Relevant Person occupies a position or undertakes a role in the AFF in which the use of drugs or alcohol by that Registered Member or Official in carrying out the Duties and responsibilities of that position would pose a risk to the health, welfare or safety of that Registered Fencer or Official, or others in a Sporting Place.
- 10.2 All information obtained through the above testing is covered by Australian privacy laws and the AFF Privacy Policy. The AFF will not use this information other than for the purposes for which it is collected. The purposes of such monitoring and examination are to ensure the productivity, health and safety of personnel, to apply this policy, and for disciplinary purposes.
- 10.3 A refusal to undergo a Drug Screen Test and/or Alcohol Screen Test or providing false information, constitutes a breach of this policy and may result in action being taken against the Registered Fencer or Official, including action as set out below under 'Breach of this Policy'.

11. BREACH OF THIS POLICY - PROHIBITED CONDUCT

- 11.1 If a Relevant Person is found to have breached this policy and actions are therefore Prohibited Conduct, and he/she may be subjected to disciplinary action in accordance with this policy and the Conduct, Disputes, and Discipline Policy. The type and severity of the disciplinary action will depend upon the circumstances of the case and the seriousness of the breach. Examples of disciplinary action that may be taken include (but are not limited to):
 - (a) a formal warning;
 - (b) suspension;
 - (c) termination of appointment or contract;
 - (d) referral to counselling, treatment or rehabilitation for drug or alcohol dependency.; and
 - (e) any other measure the AFF considers appropriate.
- 11.2 In circumstances where a Relevant Persons behaviour or conduct may involve a breach of any law, the AFF may notify the police or other relevant authority.

12. DEFINITIONS

The following are terms used in this policy:

"Activity" means a sporting contest, match, competition, event, meeting, discussion whether in person or online, or activity (including training, camp, lesson, whether online or in-person, tour where it is endorsed by a Relevant Organisation, accreditation process, high performance activity, or any such activity), whether on a one-off basis or as part of a session, series, league, or competition, which is either sanctioned, organised, co-ordinated by, or connected-with a Relevant Organisation.

"AFF" means Australian Fencing Federation Ltd.

"Alcohol Screen Test" means any analytical procedure or test which is carried out on a Registered Fencer or Official to determine the presence and/or the concentration alcohol.

"Authorised Officer" means a suitably trained, qualified and authorised person from an independent testing agency or a suitably trained, qualified and authorised person appointed by the AFF for the purposes of undertaking or arranging an Alcohol Screen Test and/or Drug Screen Test.

"Confirmatory Test" means any analytical procedure or test which is undertaken subsequent to a first Alcohol Screen Test or Drug Screen Test, which is used to verify the presence of drugs or alcohol.

"Drugs" include illegal drugs, Prescription Drugs and Pharmacy Drugs.

"Drug Screen Test" means any analytical procedure or test which is carried out on a Registered Fencer or Official to determine the presence and/or the concentration of any drug.

"Duties" includes competing, officiating, coaching, managing, administrating first aid, administration tasks and any contracted work for or on behalf of the AFF or in an AFF sanctioned activity.

"Illegal Drugs" includes:

- (a) any drug prohibited by laws to which the AFF is subject to or which apply to the Duties performed at Sporting Places or for the AFF;
- (b) Prescription Drugs or Pharmacy Drugs (as defined below) which are used without the necessary prescription or for non-medical purposes; and
- (c) any synthetic drug (whether prohibited by law or not), being a psychoactive herbal and/or chemical product which, when consumed, mimics the effects of a prohibited drug.

Member means a member of a Relevant Organisation, including:

- i. Member Organisation, which means each company or incorporated association that includes: each:
 - State or territory, referred in the AFF Constitution as a "Member State";
 and
 - iii. Affiliate that is a member of a state and territory Member (Affiliated Member, as defined in the AFF Constitution).;
- iv. **Individual Member**, which means individuals who are individuals registered with a Relevant Organisation.
- v. Any other category of membership recognised by AFF

"Official" means all persons performing duties at the direction of, or on behalf of the AFF (for example team managers, tour managers, referees, coaches, contractors, subcontractors, agents, consultants, volunteers and temporary staff).

Participant means:

- vi. Athletes:
- vii. coaches appointed to train an Athlete or Team in an Activity;
- viii. administrators who have a role in the administration, operation or Activity of a Relevant Organisation including owners, directors, committee members or other persons;
- ix. officials including referees, umpires, technical officials, or other officials appointed by a Relevant Organisation, or any league, competition, series, Club or Team sanctioned by a Relevant Organisation; and
- x. support personnel who are appointed in a professional or voluntary capacity by a Relevant Organisation, or any league, competition, series, Club or Team sanctioned by a Relevant Organisation including sports science sports medicine personnel, team managers, agents, selectors, and team staff members.
- xi. Spectator, observer or similar at an Activity, and
- xii. Parents of Athletes.
- "Pharmacy Drugs" means drugs which are lawfully available at Australian pharmacies without a prescription.
- "Prescription Drugs" means lawful drugs which are prescribed by a medical practitioner for a diagnosed medical purpose and issued by a pharmacist.
- "Registered Fencer" means a person recognised or affiliated with a state/territory fencing association that is a member of the AFF.

"Relevant Organisation" means any of the following organisations:

- xiii. AFF;
- xiv. Member Organisations; or
- xv. any other organisation that has agreed to be bound by the Relevant Policies.

Relevant Person means any of the following persons of a Relevant Organisation or at an Activity:

xvii. Individual Member;
xviii. Participant;
xviii. Employee;
xix. Contractor;
xx. Volunteer; or
xxii. any other individual who has agreed to be bound by the Relevant Policies.
```

"Sporting Places" means:

- (a) sporting places that hold any events sanctioned by the AFF including competition venues, training venues, or AFF fencing tours; and
- (b) any other places where Registered Fencers and Officials are performing Duties or representing the AFF.
