## QUALIFICATION SYSTEM – GAMES OF THE XXXIII OLYMPIAD – PARIS 2024

### INTERNATIONAL FENCING FEDERATION (FIE)

### B.4. Type of allocation of quota places:

The quota place is allocated to the athletes by name in the following individual events:

- Men's Sabre, Men's Foil, Men's Epée, Women's Sabre, Women's Foil and Women's Epée for athletes from NOCs that did not qualify through team qualification = 60 places

The quota place is allocated to the NOC in the following events/scenarios:

- Teams in Women's Sabre, Women's Foil, Women's Epée, Men's Sabre, Men's Foil and Men's Epée = 144 places.
- Host country places = 6 places (see also host country places).
- Universality places attributed by the Tripartite Commission.



## C. ATHLETE ELIGIBILITY

### Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of the FIE, may participate in the Olympic Games Paris 2024.

Athletes must comply with the minimum age requirement (set in article o.29.1 of FIE Organisation rules) and adhere to the FIE Statutes and Rules outlined in:

## D. QUALIFICATION PATHWAY

### D.1. QUOTA PLACES

**Team Qualification:** Men's Sabre, Men's Foil, Men's Epée, Women's Sabre, Women's Foil, Women's Epée

#### MEN / WOMEN

A total of 144 quota places (48 teams; 8 teams per event) will be allocated between the team events in Men's Sabre, Men's Foil, Men's Epée, Women's Sabre, Women's Foil and Women's Epée. The eight (8) teams in each of the six (6) events will be composed of three (3) athletes and will qualify as follows:

**Individual Qualification: Men's Sabre, Men's Foil, Men's Epée and Women's Sabre, Women's Foil and Women's Epée.**

**MEN / WOMEN**

The three (3) athletes from each NOC who are qualified to participate in a team event are also qualified to participate in the corresponding individual event. An additional 60 quota places (i.e., 10 quota places per event for athletes from 10 different NOCs) will be distributed between Individual Men's Sabre, Individual Men's Foil, Individual Men's Epée, Individual Women's Sabre, Individual Women's Foil and Individual Women's Epée. NOCs that did not qualify in a team event may qualify maximum one (1) athlete in the corresponding individual event through one of the following individual qualification pathways:

|  | <p>The names of all the athletes by NOC and by weapon, who have qualified through the team qualification, are removed. ## D.2. HOST COUNTRY PLACES

In addition to its possible qualification through the above-described qualification process, the host NOC will be allocated six (6) quota places, to be distributed between team and individual events as it sees fit but respecting the maximum quota of athletes per NOC and per event, and on the condition that the athletes meet the eligibility requirements described under section C of this document.

If the host NOC adds a team in a team event, it can:

- Either use two (2) quota places if it has qualified one (1) athlete in the corresponding individual event;
- Or use three (3) quota places if it has no qualified athlete in the corresponding individual event.

The three (3) athletes composing the team of the host NOC in any team event also participate in the corresponding individual event.



### D.3. UNIVERSALITY PLACES

Two (2) Universality places, one (1) per gender, are made available to eligible NOCs at the Olympic Games Paris 2024.

On 1 October 2023, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality places. The deadline for NOCs to submit their requests is 15 January 2024. The Tripartite Commission will confirm, in writing, the allocation of Universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

Detailed information on Universality Places is contained in the “*Games of the XXXIII Olympiad, Paris 2024 - Olympic Games Universality Places - Allocation Procedure and Regulations*” document.

## E. CONFIRMATION PROCESS FOR QUOTA PLACES

### E.1. CONFIRMATION OF QUOTA PLACES

The FIE will publish the list of athletes and teams qualified by 8 May 2024 on its website (<https://fie.org/fie/documents/letters>).

On 8 May 2024, the FIE will confirm in writing to the NOCs/NFs quota places obtained through team qualification and the names of the athletes who qualified through individual qualification.

The NOCs must confirm to the FIE by latest midnight (GMT+1) on 31 May 2024, the use of team quota places and the participation of each athlete qualified by name.

From 3 June 2024, the FIE will reallocate the quota places which have not been confirmed by the NOCs. See below section on Reallocation of Unused Quota Places.

### E.2. CONFIRMATION OF HOST COUNTRY PLACES

The host NOC must confirm in writing to the FIE by 20 May 2024 if it will use and for which events and genders, its host country places.

## F. REALLOCATION OF UNUSED QUOTA PLACES

In special and extreme circumstances, the reallocation period for individual and team events can be extended until 23 July 2024 (midnight GMT +1), with the agreement of the IOC, Paris 2024, the involved NOCs and the FIE, provided that the athletes are included in the long list of athletes submitted by their respective NOC to Paris 2024 by the accreditation deadline and that participation is logistically possible.



## F.1. REALLOCATION OF UNUSED QUOTA PLACES

If an allocated team or individual quota place is not confirmed by the NOC by the confirmation of quota place deadline of 31 May 2024, or is declined by the NOC, the quota place will be reallocated as follows, respecting the maximum quota per NOC and per event in section 2 above:

- If the athlete qualified through the senior AOR by zone, the quota place will be reallocated to the next highest ranked athlete in the same weapon on the senior AOR from the same zone;
- If the athlete qualified through a Zonal Qualifying Event, the quota place will be reallocated to the next highest ranked athlete in the same weapon, at the same zonal qualifying event.
- If a team qualified through the FIE Official senior Team Ranking list across all zones, the quota place will be reallocated to the next highest ranked team on the FIE Official senior Team Ranking list.
- If a team qualified through the FIE Official senior Team Ranking list by zone, the quota place will be reallocated to the next highest ranked team on the FIE Official senior Team Ranking List from the same zone.

## F.2. REALLOCATION OF UNUSED HOST COUNTRY PLACES

Any unused host country place(s) will be allocated to the Tripartite Commission for attribution of additional Universality places.

This attribution cannot cause an individual event to exceed the maximum number of 37 athletes.

## F.3. REALLOCATION OF UNUSED UNIVERSALITY PLACES

If the Tripartite Commission is not able to allocate Universality place(s), such unallocated place(s) will be attributed by the FIE to the next highest-ranked eligible athlete in the Individual senior Adjusted Official Ranking (AOR) as of 1 April 2024, across all weapons and all FIE Zones, but strictly respecting the following:

- The maximum number of athletes in each individual event (37) and
- The NOC must not have any athlete already qualified in the corresponding individual event.

## G. AP ATHLETES

### Definition:

Ap athletes are non-competing athletes accredited in the “Ap” category who have different entitlements to competing athletes (accredited as “Aa”) as described in the “Ap” accreditation quotas and conditions outlined in the IOC Accreditation Guide. These personnel are not part of the athlete quota as described in Paragraph **B. Quota Places**. “Ap” alternate athletes could become competing athletes only under the conditions outlined in the IOC/Paris 2024 Late Athlete Replacement policy (*link to be included*).





Eligibility:

“Ap” athletes must comply with the same eligibility rules as competing athletes as described in paragraph **C. Athlete Eligibility.**

Quota:

Each participating team has the right to one (1) “Ap” athlete per team event.
